Citation and Commencement This Bill may be cited as the Appropriation B i 1 1 2 0 2 5, a n d s h a 1 1 be regarded as having come into effect on the 1st of January, 2025.

Issue and 2(1) Appropriation of (₹499,451,161,110.00) The Accountant - General of the State may, when authorized to do so by warrants signed by the Commissioner charged with responsibility for Finance, pay out of the Consolidated Revenue Fund of the State during the Financial Year Commencing 1st of January, 2025 and ending 31st December, 2025 the sum of Four Hundred and Ninety-Nine Billion, Four Hundred and Fifty-One Million, One Hundred and Sixty-One Thousand, One Hundred and Ten Naira (**1499,451,161,110.00*) only.

- (2) The amount mentioned in Sub-clause (1) of this Clause shall be appropriated to Heads of expenditure as indicated in the Schedule to this Bill.
- (3) No part of the amount aforesaid shall be issued out of the Consolidated Revenue Fund of the State after the end of the year mentioned in Sub-Clause (1) of this Clause.
