### GUIDE AND PROCEDURES OF OBTAINING C OF O IN PLAGIS, PLATEAU STATE

By the power vested on the Governor of Plateau State in the Land Use Act 1978 S.5(1a) and S.9(1a, b & c) to grant a statutory Right of Occupancy and Certificate of Occupancy; the guide and procedures is the assist applicants to register with ease.



Plateau State of Nigeria, with an estimated population of over 3 million according to 2006 census is located between latitude 8 degree 24 minute N and 10 degree 30 minute N and longitude 8 degree 32 minute E and 10 degree 38 minute E and covers a total land mass of 26,899 square kilometer.

Plateau State is geographically unique in Nigeria, situated on a altitude ranges from 1,200 meters (about 4,000 feet) to a peak of 1,829 meters above sea level.

The higher altitude placed Plateau State on vantage position of cold weather. It has a near temperate climate with an average temperature between 18 degree celsius and 22 degree celsius. The Harmattan winds cause the coldest weather between December and February. The warmest temperature usually occur in the dry season months of March and April. The mean annual rainfall varies from 131.75cm (52in) in the Southern part to 146cm (57in) on the Plateau.

The highest rainfall is recorded during the wet season months of July and August. Plateau State is celebrated as "The Home of Peace and Tourism".

### PROCEDURES FOR OBTAINING CERTIFICATE OF OCCUPANCY

- 1. Download application form from <u>https://www.plateaustate.gov.ng/downloads</u> or visit Plateau State Geographic Service office to collect the application form from the front desk.
- 2. Complete and submit the application form and attach all relevant documents, including your proof of ownership, sale agreement or

confirmation of proof of ownership in case of customary land owners, from the Local Government Council in which the land is located.

- 3. A property file is open and a demand notice is raise based on the location of the property, size of the land and the use intend by the applicant- (see Rates schedule).
- 4. Payment of prescribed processing fee upon obtaining the demand notice from PLAGIS ; ALL payments must be made to the Plateau State Internal Revenue Board (PSIRS) pay points with the applicant's Tax Identification Number (TIN) and receipt issued.
- 5. Process of Right of Occupancy and Certificate of Occupancy commence. (see workflow and processing time).
- 6. Inspection of property by the Town Planning to grant permission for Right of Occupancy (see stages in the workflow).
- 7. Collection of the Right of Occupancy and acceptance of the offer (see the stage in the workflow)
- 8. Payment of outstanding ground rent to enable the continue processing of the Certificate of Occupancy (see the stage in the workflow).
- 9. Collection of Certificate of Occupancy (see the stage in the workflow)
