- 6.0 Presentation of Memo No. PLM 007, 2024 Plateau State Business Enabling Reform Action Plan (BERAP), January–December, 2023
- 6.1 The Hon. Commissioner, Ministry of Finance who presented the Memo informed Council of the State's participation in the State Action Business Enabling Reform (SABER) Programme.
- 6.1.1 She intimated Council that the State Action Business Enabling Reform (SABER) is a 3-year (2023-2025) performance-based intervention jointly designated by the World Bank Technical Team and the Presidential Enabling Business Environment Council (PEBEC) Secretariat to incentivize and strengthen the implementation of business-enabling reform across Nigeria with emphasis on the private sector development which remains the major vehicle to create more jobs, increase revenues to the States and improve social and economic outcomes for citizens.
- 6.1.2 That amongst the other Eligibility Criteria (EC) to qualify the State to participate in the 2024 SABER Program for Results (P for R) was the need for Council to consider and approve the 2023 Plateau State Business Enabling Reform Action Plan (BERAP) Progress Report.
- 6.1.3 The Hon. Commissioner stated that the precondition for the State's assessment on the 2023 activities was predicated on the need to reconsider updates made to the 2023 Plateau State Business Enabling Reform Action Plan (BERAP) Progress Report. The State SABER Team comprising Focal Persons from all relevant Ministries, Departments and Agencies, under the coordination of the Executive Governor's Strategy and Results Delivery Office (SRDQ) formerly the Programme Management and Results Delivery Office, validated the updates to the Progress Report.
